

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.youarecomplete.com, and You Are Complete LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to You Are Complete LLC include www.youarecomplete.com and YAC. The YAC website is a ecommerce site. By using the YAC website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, YAC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address

If you purchase YAC's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through YAC's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. Use of your Personal Information

Sharing Information with Third Parties

YAC does not sell, rent or lease its customer lists to third parties.

YAC may, from time to time, contact you on behalf of external business partners about a particular

offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. Automatically Collected Information

Information about your computer hardware and software may be automatically collected by YAC. Use of Cookies

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

Children Under Thirteen

YAC does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
